


Summary Paragraph

The Downtown Thermopolis Historic District (Boundary Increase) consists of four commercial buildings located at the southwest corner of the original district. Two of these buildings are contributing and the other two are non-contributing. These buildings are consistent with the district in terms of style, size, and materials. They reflect the character of downtown Thermopolis in terms of their architecture and their integral role in the commercial center of the town.

Downtown Thermopolis Historic District was originally listed in the National Register in 1984 for its significance in architecture and commerce. The period of significance is 1898-1923. Each of the buildings in this boundary expansion was built during the period of significance. The district contains mostly one and two-story buildings constructed of brick and stone.

Narrative Description

1. 531 Broadway ca. 1917 (NC)

This building has a single story and is largely covered with diagonal wood slats. The storefront is framed with aluminum and has an off-center, recessed entry with a transom. A large awning covers the width of the building above the storefront. The buildings does not retain integrity since the wood slats and awning cover over any historic material. This building first appears on Sanborn Maps in 1918 and the County Assessor lists the building date as 1917.

2. 535 Broadway ca. 1920 (C)

At the time of the original district nomination this building was covered by a metal slipcover. In 2019 those materials were removed and the building was rehabilitated to its historic appearance. The one-story building is covered with brick and has decorative diamond shaped elements on each end of the façade. The storefront has a single recessed entry. A transom with rectangular panes of glass is set above the storefront. A row of soldier course bricks lines the top of the transom. The County Assessor lists the construction date as 1917, however it does not appear on the 1918 Sanborn Map.

3. 539-41 Broadway ca. 1917 (NC)

This is a one-story building with two storefronts. Each storefront has an aluminum frame and a centered, recessed entry. The storefronts are separated by a column of bricks. The area above the storefronts is covered by an applied signboard, which obscures any historic materials. The building lacks sufficient historic integrity due to changes in material in the storefronts and the covering of historic materials above the storefronts. This building first appears on Sanborn Maps in 1918 and the County Assessor lists the building date as 1917.

4. 109 S. 6th Street ca. 1917 (C)

This two-story building is located on the southeast corner of Broadway and 6th Street. It is a highly visible building on a busy intersection in Thermopolis. The north façade facing Broadway has a single storefront that is covered with wood siding. The eastern half of the storefront is flush with the façade, and the western half slants back to the central entry. A shed awning is above the storefront. The upper story has three single-pane windows. Above the windows is a cornice with diamond shaped brick accents. The west façade along 6th Street is much longer and has three entrances. The two northernmost entries are aluminum frame doors recessed in bays with vertical wood siding. The other entry is an aluminum frame door in a storefront with wood siding. Two of the entries are covered by a large metal shed awning. The second floor has a total of 13 windows. Most of the windows are one-over-one double-hung. Above the windows is the same diamond shaped brick elements seen on the north façade. This building first appears on Sanborn Maps in 1918 and the County Assessor lists the building date as 1917.

Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance and applicable criteria.)

The Downtown Thermopolis Historic District (Boundary Increase) is located on the south side of Broadway and extends east from 6th Street. This boundary increase consists of four buildings that were built within the district's period of significance. The boundary increase is eligible for listing in the National Register of Historic Places under criterion A for commerce and criterion C for architecture. These buildings fit within the historic context of downtown Thermopolis as described in the original nomination for the Downtown Thermopolis Historic District.

The town of Thermopolis developed quickly in the first couple decades of the twentieth century as widespread mineral exploration brought an influx of new residents and businesses. In 1906 copper and magnesium deposits were discovered outside of town and in 1913 the first oil rigs were placed. Then, in 1916, sulphate of potassium, which is used in fertilizers, was discovered in the area. Also, the natural mineral hot springs in town drew both entrepreneurs and visitors.

The natural minerals found in the surrounding landscape made the area attractive for agriculture and industry. Fertilizer plant was located just outside of town and the mineral waters were bottled and shipped out on the railroad. To keep pace with the demands of the growing population the downtown area emerged quickly in the 1910s and 20s. The initial buildings were constructed of a native sandstone and subsequent buildings were from a locally produced brick. After the 1920s the development of the town slowed considerably and the downtown district saw little to no new construction.

The buildings in the Downtown Thermopolis Historic District (boundary increase) housed a variety of commercial interests. The building at 531 was listed in Sanborn Maps as a billiards hall, 539-41 was listed as the Thermopolis Motor Company, and 109 S. 6th Street held a saloon and moving pictures. These buildings, through their various uses, added to the commercial viability of downtown Thermopolis.




Figure 1: Original Thermopolis Downtown Historic District boundary




Figure 2: Expanded Thermopolis Downtown Historic District boundary.
